When in a hotel or office building, please request an analog or fax line from the concierge or facilities personnel.

Do NOT connect your modem to an ISDN line. In some countries, ISDN (digital) lines are being provided for residences and businesses. These lines may damage the modem.

Please note that this modem is fully compatible with analog telephone lines that are connected to a Digital Exchange. The Digital Exchange supplies analog lines to homes and businesses.

#### Installing Modem in Windows 3.x and NT 4.0

- 1. For NT, Check the Devices applet in the Control Panel to make sure PCMCIA support is enabled. The startup type should be "boot" and the status should say "started".
- 2. Power off your computer.
- 3. Insert the modem card into a PCMCIA card slot on your computer. Make sure that the card is completely inserted and mated securely to the computer.
- 4. Connect one end of the RJ11 phone cable to the XJACK® connector on the modem.
- 5. Connect the other end of the modem cable to an analog telephone line
- 6. Power on your computer, start Windows The modem is now ready for use.

#### Installing Modem in Windows95

#### Additional Information for Installing with Windows NT 4.0

- After power on, open Control Panel
- Double click Modems icon
- Install New Modem panel should appear on your screen
- Check **don't detect modem**
- Click NEXT
- Insert supplied Windows95 Installation diskette in diskette drive
- Click on OK
- Under Models, you should see IBM 56K Data-Fax Modem
- Remove diskette, click on NEXT
- Windows NT 4.0 will request you select a com port, select any one then click on **NEXT**.
- If NT says it is unable to add modem to com port, click **OK** and re-run modems from control panel but do NOT select **don't detect modem**. Windows NT 4.0 will then correctly assign the modem to a com port.

#### Vertifying OS/2 COM port setting

- Open System Setup in System folder.
- Double click on the **Plug-and-play** icon.
- You should see **modem configured in** the slot number the modem is in.
- To find out which COM port the modem is assigned to, select the slot and double click on it.
- This will display the COM port and IRQ ( interrupt ) that is assigned to the modem.

### Part 4: Testing Your Modem

Refer to the Application Software's Installation Manual to load the communications software you will be using.

- 1. Turn on your computer.
- 2. Start your communication software and be sure it is in the command mode. This is also known as terminal mode.
- 3. Setup your communication software to 19200 and the communication port your modem is using.
- 4. If the port opened properly, go to the next step. Otherwise, check if you have any other communication software trying to use the same port. If so, close that software. If not, switch to a different COM port.
- 5. Type **AT&F** and press **enter**, you should see an **OK** response. If nothing happened at this point, this indicates that the modem is not getting the proper IRQ.
- 6. Type AT\N1 and press enter
- 7. Type ATE1 and press enter
- 8. Type **ATS18=n** and press enter

NOTE: n is the number of seconds (30-255) you want the test to last.

- 9. Type **AT&T1** press **enter**. You should see **CONNECT nnnnn** (n is the connect speed you selected) displayed on your screen. After the CONNECT message, the modem is in the data mode. You can type any character on your keyboard and see them displayed on your screen.
- 10. When the time you specified in register S18 expires, you see **OK** displayed on your screen.
- 11. Type **AT&F** and press **enter**, you should see an **OK** response on your screen.

#### **Dial Tone Test**

- 1. Turn on your computer.
- 2. Start your communication software and be sure it is in the command mode. This is also known as terminal mode.
- 3. Setup your communication software to the communication port your modem is using.
- 4. Type **ATZ** and press **Enter**.

Typing this command sets the modem to the default values. Your modem responds by displaying **OK** on your screen.

5. Type **ATL3** and press **Enter**.

Typing this command increases the volume level at the modem speaker. Your modem responds by displaying **OK** on your screen.

6. Type **ATD** and press **Enter**.

You should hear a dial tone from the modem speaker.

7. Press Enter.

You should no longer hear the dial tone. Your modem responds by displaying **NO Carrier** on your screen.

This completes the Dial Tone Test

## Part 5: Help and Service Information

Before calling, please prepare for your call by following these steps.

#### **Step 1: Troubleshooting**

The modem was completely tested for proper operation at the factory before packaging for shipment. If the modem does not respond to the **AT** commands described in *Testing your modem*, please try the following:

- Ensure that the modem is properly seated in your computer by removing and re-inserting the modem.
- Verify that the COM port specified in your communications software is the same as the COM port to which your modem is set..
- Ensure that the communications software is installed properly. Follow the installation instructions for the communications application carefully, and check the documentation for any additional information pertaining to your system.

#### **Step 2: Preparing for the Call**

To assist the technical support representative, have available as much of the following information as possible:

- Option name, description and serial number (if any)
- Order and or Field Replaceable Unit (FRU) part numbers
- Proof of purchase
- Computer manufacturer, model, serial number (if IBM) and manual
- Exact wording of the error message (if any)

#### **Production Status**

Each Machine is manufactured from new parts, or new and used parts. In some cases, the Machine may not be new and may have been previously installed. Regardless of the Machine's production status, IBM's warranty terms apply.

#### The IBM Warranty for Machines

IBM warrants that each Machine 1) is free from defects in materials and workmanship and 2) conforms to IBM's Official Published Specifications. The warranty period for a Machine is a specified, fixed period commencing on its Date of Installation. The date on your receipt is the Date of Installation, unless IBM or your reseller informs you otherwise.

During the warranty period IBM or your reseller, if authorized by IBM, will provide warranty service under the type of service designated for the Machine and will manage and install engineering changes that apply to the Machine.

For IBM or your reseller to provide warranty service for a feature, conversion, or upgrade, IBM or your reseller may require that the Machine on which it is installed be 1) for certain Machines, the designated, serial-numbered Machine and 2) at an engineering-change level compatible with the feature, conversion, or upgrade.

Many of these transactions involve the removal of parts and their return to IBM. You represent that all removed parts are genuine and unaltered. A part that replaces a removed part will assume the warranty service status of the replaced part.
